Fund Description

Capital Campaign: This is the fund that pays for ongoing improvements to the physical facilities here at camp. There is a \$25,000 matching gift that has been given to this fund. Matching funds must be committed before December 31st, 2016. Camp will use these funds in the construction/completion of new buildings and facilities or in some cases, major repairs. Ex: Completion of the 4-plex, heating and cooling new kitchen and dining hall.

General Fund: You have bills, so do we. This fund is the fund from which we pay our monthly and ongoing obligations. Camper fees only cover about 30% of the total of our annual expenses. Gifts to the general fund allow us to keep fees low. We never turn away a camper for lack of funds.

Designated support for Glenn Smith and family: Glenn is the full time director at Camp Witness. As the first director to have no other outside income, funds designated to Director Support allow for him to focus his full attention on the ministries of the camp as well as seek ways to expand the impact of camp in new ways. A designated gift helps meet the financial needs of the Smith family. Please consider monthly support. Monthly support allows for better planning for general family expenses.

Designated support for future Program Director: The position of program director will be created and hopefully filled soon. This position will be responsible for planning and execution of the summer camp program. They will have an emphasis on staff recruiting and daily operation of the regular camp activities. A significant portion of this full-time position will be financed through designated giving. If you have further questions, please ask the director. You will be given opportunity to meet casually with the person before making any financial commitment.

Special Projects: Camp Witness has a vision to continue to improve the facilities we use to reach youth and adults for God's kingdom. If you have a desire to discuss larger projects that in our vision for the future, but for which camp lacks the capital to move forward, please contact the director to discuss options.

Non-monetary Items: Throughout the year, Camp Witness receives gifts of non-monetary items. Please contact camp before making a non-monetary donation. Camp has limited storage and items that can't be used in a timely manner may not be able to be cared for in a manner that is the best stewardship of your gift. A tax deductible receipt is available for the market value of the item upon request. Note: To meet specific regulatory requirements, some food items have specific restrictions. Ex: Meat served during the camp season should come from a USDA inspected facility.
